## WAIVER AND RELEASE

Knowing the risks involved, nevertheless I request permission to be in the Camp for all activities and hereby agree to assume any and all risks of injury or death and to release and hold harmless East Valley Juniors who through negligence, carelessness, or other acts or omissions might otherwise be liable to me. I further understand and agree that this waiver, release, and assumption of risk is binding on my heirs, assigns, and potential subrogees, including any insurance company and/or HMO.

I further agree to indemnify and to hold harmless East Valley Juniors from any loss, liability, damage, or expense, including attorney fees, that it may incur as a result of any injury and/or property damage that I may sustain or cause while in the Camp and I further agree to reimburse any expense that East Valley Juniors may incur if any litigation arises because of any claim made by me or another injured by my actions in the Camp.

I HAVE CAREFULLY READ THIS WAIVER AND RELEASE AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A FULL RELEASE OF LIABILITY OF EAST VALLEY JUNIORS AND, BY MY SIGNATURE INTENTIONALLY RELINQUISH ANY RIGHTS AS SET FORTH ABOVE.
