

# EVJ Beach Volleyball Program (EVJ Beach)

## 2014 BEACH CLUB PARTICIPATION AGREEMENT

I/We the parents/guardians of \_\_\_\_\_ have received the Program Information Sheet and the Parent-Player Handbook concerning the policies and rules and regulations of the EVJ Beach Volleyball Program.

I/We agree that our daughter, having been selected to participate in the Program, will join EVJ Beach for the 2014 season. **We understand we are responsible for all fees for the entire season, payable at the specified due dates**, as well as transportation for our daughter to practices and to tournaments. The EVJ Beach Volleyball Program is not sanctioned by the AZ Region; however, players are required to be registered members to participate in the AZ Region Junior Beach Program as well as USAV and CBVA events. I/We understand it is our responsibility to register with all aforementioned organizations and pay for all membership and tournament entry fees as laid out in the "Tournament Entry & Registration Checklist/Guide" provided to me/us.

I/We have read all the materials provided and understand the time commitment involved in practice and in competition. I/We agree that if our daughter is placed in the travel program, that we are required to make our own travel arrangements, sign up and pay for each tournament on our own, and cover our own travel costs.

I/We agree that if for any reason our daughter does not abide by the rules and regulations of EVJ Beach or USA Volleyball, that she may be removed from the program. These rules are basic:

1. Caught with or use of drugs or alcohol.
2. Using abusive language.
3. Being arrested for any offense.
4. Stealing or destruction of property.
5. Not following the rules/instructions given by a coach.

**We have reviewed the Fee Schedule on the Program Information Sheet and I/we understand that all fees must be paid in full, regardless of the duration of participation by the individual.** I/We understand that participation at EVJ Beach is limited, and that others were denied a position by our acceptance of a position in the program at EVJ Beach. Adjustments will be made to the extent possible in the event of an injury to a player.

I/We agree to pay all fees per the Fee Schedule determined by the program our daughter is selected for. I/We understand that a non-refundable deposit is due the day of tryouts if our daughter is selected for the program. The balance is due in two monthly installments on April 15 and May 15. A late fee of \$25 will be assessed if the payment is not received in the mail by the end of the night on the 20<sup>th</sup> of the month. **Checks are payable to EVJ Volleyball.** If the fees are not paid, I/we agree to pay any collection costs and attorney fees incurred on behalf of EVJ Beach to collect unpaid fees.

Having read the aforementioned items and the Parent-Player Handbook regarding the policies of EVJ Beach and having discussed them with my/our daughter, we agree to abide by the rules of EVJ Beach and will support her participation. **We are committing to full participation in the EVJ Beach Volleyball Program for the 2014 season.**
